Analyzing Provider Claims

Perhaps the biggest problem area for Sponsors lies in analyzing Provider claims. You've got to calculate each Provider's reimbursement, but you must also identify any claiming problems.

- school-aged children aren't served AM Snack or Lunch, unless the child is out of school for a reason
- the provider isn't over capacity, even if the provider splits a meal into two shifts of children
- the foods & attendance observed during a home visit by a field rep match the foods & attendance recorded by the provider
- children aren't claimed at more than 2 meals & a snack or 2 snacks & a meal each day
- much, much more
